On May 8, 2014, MEDNAX, Inc., a Florida corporation (the Company), held its 2014 Annual Shareholders Meeting (the Annual Meeting). Of the 100,199,859 shares of common stock outstanding and entitled to vote, 90,522,627 shares were represented, constituting a quorum.
