### Item 1.01 Entry into a Material Definitive Agreement.

# Item 2.03 Creation of a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant.

On December 15, 2014, MEDNAX, Inc., a Florida corporation (the Company), entered into an uncollared accelerated share repurchase (ASR) agreement with JPMorgan Chase Bank, N.A. (JPMorgan), to repurchase \$200 million of the Company s common stock.

Under the terms of the ASR agreement, the Company made a \$200 million payment to JPMorgan on December 17, 2014 and received an aggregate initial delivery of approximately 2.5 million shares of the Company s common stock on December 18, 2014. The final number of shares to be repurchased will be based on the volume-weighted average share price of the Company s common stock during the term of the ASR agreement, minus a discount and subject to adjustments pursuant to the terms and conditions of the ASR agreement. At settlement, under certain circumstances, JPMorgan may be required to deliver additional shares of common stock to the Company or the Company may be required to deliver shares of its common stock or to make a cash payment, at its election, to JPMorgan. The final settlement of the transactions under the ASR agreement is expected to occur within seven months. The Company is funding the ASR with borrowings under its existing \$1.3 billion unsecured revolving credit facility.

The ASR agreement contains customary terms for these types of transactions, including, but not limited to, the mechanisms to determine the number of shares or the amount of cash that will be delivered at settlement, the required timing of delivery of the shares, the specific circumstances under which adjustments may be made to the transactions, the specific circumstances under which the transactions may be terminated prior to its scheduled maturity and various acknowledgements, representations and warranties made by the Company and JPMorgan.

The ASR is being executed as part of an authorization by the Company s Board of Directors to repurchase up to \$600 million of the Company s common stock, announced on October 30, 2014. Including shares to be repurchased under the ASR and open market purchases, a total of \$361 million of shares will have been repurchased to date under this authorization.

The \$600 million authorization is incremental to the Company s existing authorization to repurchase its common stock up to an amount sufficient to offset the dilutive impact from the issuance of shares under the Company s equity programs. The Company will continue to contemplate various methods to effect future share repurchases, including, among others, open-market purchases and additional accelerated share repurchase programs, which may be implemented during the term of the current ASR.

From time to time, JPMorgan and/or its affiliates have directly and indirectly engaged, and may engage in the future, in transactions with the Company for which they have received, or may receive, customary compensation, fees and expense reimbursement.
