**EXPLANATORY NOTE / DEREGISTRATION OF SECURITIES**

These Post-Effective Amendments, filed by Famous Dave's of America, Inc. (the Company), relate to the following Registration Statements filed by the Company on Form S-3 (collectively, the Registration Statements):

Registration Statement No. 333-95311, originally filed with the U.S. Securities and Exchange Commission (the SEC) on January 25, 2000, as amended on March 17, 2000, pertaining to the registration of 421,610 shares of the common stock of the Company (Common Stock) issuable upon the exercise of warrants;

Registration Statement No. 333-48492, originally filed with the SEC on October 24, 2000, pertaining to the registration of 195,000 shares of Common Stock;

Registration Statement No. 333-54562, originally filed with the SEC on January 29, 2001, pertaining to the registration of 36,200 shares of Common Stock;

Registration Statement No. 333-65428, originally filed with the SEC on July 19, 2001, pertaining to the registration of 329,200 shares of Common Stock;

Registration Statement No. 333-73504, originally filed with the SEC on November 16, 2001, pertaining to the registration of 1,000,000 shares of Common Stock; and

Registration Statement No. 333-86358, originally filed with the SEC on April 16, 2002, pertaining to the registration of 26,000 shares of Common Stock.
