OZ and OZ Management II LP ( OZII ) each serves as the principal investment manager to the Accounts. OZII is a wholly-owned subsidiary of OZ and, as such, OZ may be deemed to be the beneficial owner of American depository shares (five American depository shares representing one Class A ordinary share, par value HK\$1.00 each) ( ADRs ) held in the Accounts managed by OZII. OZ is the sole member of Och-Ziff Holding II LLC ( OZHII ), the general partner of OZII. As a result, OZ has voting and dispositive authority over the ADRs reported in this Schedule 13G. OZHC serves as the sole general partner of OZ. As such, OZHC may be deemed to control OZ and, therefore, may be deemed to be the beneficial owner of the ADRs reported in this Schedule 13G. OZM is the sole shareholder of OZHC, and, for purposes of this Schedule 13G, may be deemed to be the beneficial owner of the ADRs reported in this Schedule 13G. Mr. Daniel S. Och is the Chief Executive Officer and an Executive Managing Director of OZM. As such, for purposes of this Schedule 13G, he may be deemed to control such entity and, therefore, be deemed to be the beneficial owner of the ADRs reported in this Schedule 13G.

The percentages used in this Item 4 are calculated based on 58,598,173 shares of Class A ordinary shares, par value HK\$1.00 each, outstanding as of June 30, 2015, as reported in the Issuer's Exhibit 99.1 to its Form 6-K filed on August 10, 2015.
