**Item 8.01. Other Events.**

On February 25, 2019 Atmos Energy Corporation ( Atmos Energy ) entered into an underwriting agreement (the Underwriting Agreement ) with BNP Paribas Securities Corp., CIBC World Markets Corp., Credit Agricole Securities (USA) Inc. and Wells Fargo Securities, LLC, as representatives of the several underwriters named in Schedule I thereto, with respect to the offering and sale in an underwritten public offering (the Offering ) by Atmos Energy of \$450 million aggregate principal amount of its 4.125% Senior Notes due 2049 (the Notes ), with a yield to maturity of 4.148% and an effective yield to maturity of 4.862%, after giving effect to related fees, original issuance discount and the settlement of interest rate swaps. The Offering has been registered under the Securities Act of 1933, as amended (the Securities Act ), pursuant to a registration statement on Form S-3 (Registration No. 333-228342) of Atmos Energy (the Registration Statement ) and the prospectus supplement dated February 25, 2019, which was filed with the Securities and Exchange Commission pursuant to Rule 424(b) of the Securities Act on February 27, 2019. Legal opinions related to the Registration Statement are also filed herewith as Exhibits 5.1 and 5.2.

Atmos Energy expects to receive net proceeds, after the underwriting discount and estimated offering expenses, of approximately \$443 million. The Offering is expected to close on or about March 4, 2019, subject to customary closing conditions.

The Notes will be issued pursuant to an indenture dated March 26, 2009 (the Indenture ) between Atmos Energy and U.S. Bank National Association, as trustee (the Trustee ), to be modified by an Officers Certificate setting forth the terms of the Notes (the Officers Certificate ), to be dated March 4, 2019 and delivered to the Trustee pursuant to Section 301 of the Indenture. The Notes will be represented by a global security, a form of which is filed as an exhibit hereto. The form of Officers Certificate and the Underwriting Agreement are each also filed as an exhibit hereto.
