This represents the grant of a performance-based restricted stock award that has restrictions that lapse at varying rates based on certain performance-based criteria. The award has an "overdrive" feature that provides that if the Compound Annual Growth Rate ("CAGR") of

- (1) the Company's core EPS for FY06 through FY08 is in excess of a certain specified percentage the reporting person is entitled to additional shares. The number of shares listed in Column 4 of Table 1 represents the maximum of shares that may be issued pursuant to the award if the CAGR maximum target is met.
- (2) \$0.00 has been inserted to satisfy the requirements to submit this form via the EDGAR system.
- (3) Column 5 of Table I includes 596 shares and 602 shares acquired on June 30, 2005 and December 31, 2004, respectively, under the 2002 Employee Stock Purchase Plan of Jabil Circuit, Inc.
- (4) Stock Appreciation Rights shall vest at the rate of one-twelfth of the initial shares subject to the award one year and three months after the date of grant (which date of grant was 10/11/2005), with an additional one-twelfth of the initial shares subject to the award vesting on the same calendar date of each successive three month period thereafter, with, as a result, all of the initial shares subject to the award vesting by four years from the date of grant; provided that in all instances the reporting person is an employee of, or consultant (as defined in the

relevant stock incentive plan) to, the Company or a subsidiary.
