Novo Nordisk A/S Share repurchase programme

On 12 August 2010 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission's regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 1.0 billion in the period from 12 August 2010 to 25 October 2010. Consequently, the programme has been concluded on 25 October 2010.

Since the announcement as of 18 October 2010, the following transactions have been made under the programme:
