Novo Nordisk A/S – Share repurchase programme

On 2 May 2012 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission's regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk has repurchased B shares for an amount of DKK 1.8 billion in the period from 2 May 2012 to 3 August 2012. The programme is now concluded.

Since the announcement as of 30 July 2012, the following transactions have been made under the programme:

Novo Nordisk expects to repurchase B shares worth DKK 12.0 billion during a 12 month period beginning 2 February 2012. As of 3 August 2012, Novo Nordisk has repurchased a total of 10,365,758 B shares equal to a transaction value of DKK 8,499,999,378.
