## **Novo Nordisk A/S – Share repurchase programme**

**Bagsværd, Denmark, 21 January 2013** – On 9 November 2012 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission’s regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 1.5 billion in the period from 9 November 2012 to 29 January 2013.

Since the announcement as of 14 January 2013, the following transactions have been made under the programme:

With the transactions stated above, Novo Nordisk owns a total of 18,123,616 treasury shares, corresponding to 3.2% of the share capital. The total amount of shares in the company is 560,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares worth DKK 12.0 billion during a 12 month period beginning 2 February 2012. As of 18 January 2013, Novo Nordisk has repurchased a total of 13,764,357 B shares equal to a transaction value of DKK 11,680,085,283.
