The Reporting Person has received a refund of certain amounts contributed to the Company?s 401(k) Plan. Under the terms of the Key

(1) Employees? Deferred Compensation Program (the "Program"), this refund is converted into Units representing shares of The Brink?s Company ("BCO") Common Stock and credited to the Reporting Person's account in accordance with the terms of the Program.

(2) The number of Units credited to the Reporting Person?s account on the Transaction Date is based upon a share price of \$60.32, which is the average trading price of BCO Common Stock for the month of March 2007, calculated in accordance with the terms of the Program.

On the first business day of each month, the amount of salary deferred to the Reporting Person?s account during the previous month, plus any matching amounts, is converted into Units representing shares of BCO Common Stock and credited to the Reporting Person's account in accordance with the terms of the Program.

(4) The number of Units credited to the Reporting Person?s account on the Transaction Date is based upon a share price of \$63.37, which is the average trading price of BCO Common Stock for the month of April 2007, calculated in accordance with the terms of the Program.
