- (1) Pursuant to the Endo Pharmaceuticals Directors Stock Election Plan, on November 29, 2010, Mr. Scodari elected to receive 100% of his 2011 cash retainer fees and 100% of his 2011 meeting fees in Endo common stock. At the time that the retainer and meeting fees would otherwise have been payable, the number of shares of Endo common stock are fixed and are reported as of such date on Table I as an acquisition of securities. These cash retainer and meeting fees are payable to Mr. Scodari in consideration of his services on the Endo Pharmaceuticals Holdings Inc. Board of Directors and Compensation Committee for the fourth quarter 2011 meetings and the fourth quarter 2011 retainer fee.
- (2) This number represents (i) 5,677 restricted stock units and (ii) 16,877 shares of common stock. Mr. Scodari's beneficial ownership disclosed in this table excludes all shares held by Mr. Scodari indirectly, including shares underlying stock options.
