(2) The reporting person is one of the managing members of Duchossois Technology Partners, L.L.C. ("Duchossois"), and may be deemed to share voting and dispositive power with respect to the shares held by Duchossois. (5) Each share of the issuer's Series D Convertible Preferred Stock automatically converted into 1/3 share of the issuer's Common Stock on April 25, 2012 pursuant to an election by the holders of a majority of the shares of preferred stock of the issuer in connection with the closing of the issuer's sale of its Common Stock in its firm commitment initial underwritten public offering pursuant to a registration statement on Form S-1 under the Securities Act of 1933, as amended, and had no expiration date.
