(1) The sales reported on this Form 4 by Mr. Berman were effected pursuant to a Rule 10b5-1 Trading plan adopted by Mr. Berman on May 31, 2012.

(2) The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$23.00 to \$23.22. The reporting person undertakes to provide to Dorman Products, Inc., any security holder of Dorman Products, Inc. or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the range set forth in this footnote.

(3) These shares were sold by a limited partnership for which the reporting person is (i) a limited partner and (ii) a controlling shareholder of the general partner of such partnership. The reported securities represent only the reporting person's pecuniary interest in the securities sold by the Partnership on the Transaction Date.
