(2) Investment Fund-A, L.P. ("Strategic Fund-A") and Triam SPV (SUB) V, L.P. Mr. Peltz is a member of Triam Fund Management GP, LLC, which is the general partner of Triam Management, and therefore is in a position to determine the investment and voting decisions made by Triam Management on its own behalf and on behalf of the Triam Entities.
