The shares underlying the stock option vest in monthly installments as follows: (a) 10% of the shares vest in equal monthly installments over the 12 month period following the grant date; then (b) 20% of the shares vest in equal monthly installments over the following 12 (1) month period; then (c) 30% of the shares vest in equal monthly installments over the following 12 month period; and then (d) 40% of the shares vest in equal monthly installments over the following 12 month period, such that all of the shares subject to the stock option will be vested as of the fourth anniversary of the grant date.

(2) The shares underlying the stock option vest in equal monthly installments over 24 months following the grant date.
