- (1) Award of annual restricted stock units, each of which represents a contingent right to receive one share of Athersys, Inc. common stock after vesting. The restricted stock units vest ratably on a quarterly basis over a four-year period.
- (2) Securities beneficially owned are comprised of: (1) 543,751 shares of common stock owned, (2) 231,680 restricted stock units awarded on June 20, 2013 related to the termination of 2005 incentive agreements that will vest ratably on a quarterly basis through June 18, 2016, and (3) restricted stock units awarded on an annual basis amounting to 158,488 that vest quarterly over a four-year period from grant date.
- (3) Award of an annual incentive stock option. The option vests ratably on a quarterly basis over a four-year period.
