(1) Pursuant to the Issuer's Amended and Restated 2008 Executive Performance Incentive Plan and the terms of the related award agreement, each time shares of common stock are issued upon the vesting of restricted stock units, a portion of the shares are automatically withheld by the Issuer to satisfy the resulting tax withholding obligation. In connection with the vesting of 2,490 restricted stock units held by the Reporting Person on 03/06/2016, the issuer has withheld 682 shares of common stock to satisfy the resulting tax withholding obligation.
