- (1) The purchases reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on August 13, 2015.  
  
The price reported in Column 4 is a weighted average price. The common units were purchased in multiple transactions at prices ranging from \$7.87 - 8.00, inclusive. The Reporting Person undertakes to provide to StoneMor Partners L.P. (the "Partnership"), any holder of common units of the Partnership, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of common units purchased at each separate price within the range set forth in this footnote (2) to this Form 4.
  - (2) The price reported in Column 4 is a weighted average price. The common units were purchased in multiple transactions at prices ranging from \$7.65 - 7.87, inclusive.
  - (3) Represents the proportionate interest of the Reporting Person in 2,332,878 common units of the Partnership issued and sold to StoneMor GP Holdings LLC ("GP Holdings") by the Partnership, which purchase was funded by the purchase of common units of GP Holdings by a trust for the pecuniary benefit of American Cemeteries Infrastructure Investors, LLC.
  - (4) The Reporting Person is a member of GP Holdings. The Reporting Person also holds membership interests in GP Holdings through Ten Twenty, L.P.
  - (5) The Reporting Person disclaims beneficial ownership of the common units except to the extent of his pecuniary interest therein.
  - (6) The Reporting Person is a general partner of Ten Twenty, L.P.
  - (7) The general partner of Osiris Investments, LP is Osiris Investments LLC. Lawrence Miller and William R. Shane are each a 50% member of Osiris Investments LLC and share investment and voting power over the securities held by Osiris Investments, LP. Mr. Miller and Mr. Shane file separate Section 16 reports.
