On February 4, 2015, the reporting person was granted 4,400 performance share units. The performance share units were eligible to vest based on achievement of a cumulative earnings per share goal for fiscal years 2015-2017. The number of performance share units that

- (1) were eligible to vest varied from zero (for actual performance less than 80% of target) to two times the units granted (for actual performance of 120% or more of target). Based upon the Company's achievement with respect to cumulative 2015-2017 earnings per share, the number of performance share units that vested equaled two times the units granted.
- (2) Includes 1,424.4249 shares acquired under the HCA Holdings, Inc. Employee Stock Purchase Plan.
- (3) Restricted stock units convert into common stock on a one-for-one basis.

On February 5, 2014, the reporting person was granted 17,500 stock appreciation rights. The stock appreciation rights were eligible to vest in equal increments of up to 25% at the end of fiscal years 2014, 2015, 2016 and 2017 based upon the extent to which certain

- (4) EBITDA performance targets have been met for the applicable fiscal year. Based upon the Company's achievement with respect to the EBITDA performance criteria for 2017, 60% of the stock appreciation rights subject to such criteria vested, resulting in the vesting of 2,625 stock appreciation rights.
- (5) On February 25, 2015, the reporting person was granted 1,414 restricted stock units, vesting in two equal annual installments beginning on the second anniversary of the grant date.
- (6) On February 25, 2016, the reporting person was granted 1,581 restricted stock units, vesting in two equal annual installments beginning on the second anniversary of the grant date.
