- (4) On May 24, 2018 the Reporting Person was granted an RSU for 8,303 shares of the Issuer's Common Stock, vesting annually for so long as the Reporting Person provides continuous service to the Issuer with (i) 50% vesting on the last market trading day immediately prior to Issuer's first annual stockholder meeting held after May 24, 2018, and (ii) 50% vesting on the last market trading day immediately prior to Issuer's second annual stockholder meeting held after May 24, 2018.
