(1) 8,740 performance shares ("PSUs") were earned as of 02/08/2019 per the Republic Services, Inc. Amended and Restated 2007 Stock Incentive Plan based on Republic's closing stock price on 02/08/2019 (\$76.68). Such PSUs were deferred under the Republic Services, Inc. Deferred Compensation Plan as elected by the Reporting Person. The deferred PSUs will accumulate quarterly dividend equivalents.

(2) Restricted Stock Units ("RSUs") awarded pursuant to Republic Services, Inc. Amended and Restated 2007 Stock Incentive Plan. The award will vest 25% on each of the first four anniversaries of the date of grant (which date of grant is 02/08/2019) and each RSU ultimately will be paid out in the form of one share of Republic's common stock. The number of RSUs was calculated based on Republic's closing stock price on 02/08/2019 (\$76.68).
