- (1) Represents 5% vesting on March 7, 2019. The original grant was 10,054 restricted stock units, with 20% vesting on March 7, 2015, and the remaining 80% vesting in equal quarterly installments over the remaining 4 years.

- (3) Each restricted stock unit represents the right to receive, following vesting, one share of the issuer's common stock.
