(1) Between July 2005 and June 2006, the reporting person acquired 51 shares of Affiliated Computer Services, Inc. Class A Common Stock, par value \$0.01 under the Affiliated Computer Services, Inc. 401k Plan (the "Plan") at purchase prices ranging from \$47.62 to \$63.20 per share.

(2) Between July 2005 and June 2006, the reporting person acquired 222 shares of Affiliated Computer Services, Inc. Class A Common Stock, par value \$0.01 under the Affiliated Computer Services, Inc. Employee Stock Purchase Plan at purchase prices ranging from \$51.10 to \$59.66 per share.

(4) These options vest and become exercisable as follows: on each anniversary date of the grant, commencing with the first such anniversary date and continuing on each such anniversary thereafter through and including the fifth anniversary of the date of the grant, 20% of such options shall vest and become exercisable. The date of grant is 10 years prior to the stated expiration date.

(5) These options vest and become exercisable as follows: on the third anniversary date of the grant, 60% of such options will vest and become exercisable; and on each of the fourth and fifth anniversary dates of the grant, 20% of such options will vest and become exercisable. The date of grant is 10 years prior to the stated expiration date.
