- (2) Between July 2004 and June 2005, the reporting person acquired 279 shares of Affiliated Computer Services, Inc. Class A Common Stock, par value \$0.01 under the Employee Stock Purchase Plan at purchase prices ranging from \$51.10 to \$60.19 per share.

 (4) each such anniversary thereafter through and including the fifth anniversary of the date of the grant, 20% of such options shall vest and become exercisable. Date of Grant is 10 years prior to stated expiration date.
- On February 2, 2005, the Board of Directors approved changes in the exercisability of options, such that these options now vest and become exercisable as follows: on the third anniversary date of the grant, 60% of such options will vest and become exercisable; and on  
 (5) each of the fourth and fifth anniversary dates of the grant, 20% of such options will vest and become exercisable. Date of Grant is 10 years prior to stated expiration date.
- (6) The Exercise Price per share is \$15.65625.
