(1) Annual grant of restricted stock units pursuant to the Company's 2009 Global Incentive Plan, as amended and Restated February 9, 2017. The restricted stock units vest in full on the one-year anniversary of the date of the grant.

(2) Upon vesting of 1,717 Restricted Stock Units granted to the reporting person on April 21, 2016, the reporting person deferred the receipt of 1,717 shares of Series A Common Stock and received instead 1,717 shares of phantom stock pursuant to the Company's 2008 Deferred Compensation Plan. As a result, the reporting person is reporting the disposition of 1,717 shares of Series A Common Stock in exchange for an equal number of shares of phantom stock.

(3) Each share of phantom stock represents the right to receive one share of Series A Common Stock.

(4) As provided in the 2008 Deferred Compensation Plan, on the earlier date previously elected by the reporting person to receive payment or the termination of the reporting person's service as a director of the Company, the reported phantom stock becomes payable in shares of Series A Common Stock subject to certain limitations.
