- (1) Includes 47,453 shares acquired through the reinvestment of dividends on April 2 and July 3, 2008, at a prices ranging from \$28.64 - \$35.34 per share.

- The share balance includes an award of 7,500 shares of restricted stock which will vest on August 1, 2011, and 30,000 shares of restricted stock which will vest in 50% increments on November 1, 2009, and November 1, 2011, based on continuous employment with the company.

- (2) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's restricted stock.

- (3) Includes 311.74 phantom stock units acquired through the reinvestment of dividends on April 2 and July 3, 2008, at prices ranging from \$28.62 - \$35.18 per phantom stock unit.

- (4) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
