Value attributable to such Rights, if any, is reflected in the market price of the common stock.

- (1) Vesting on 05/04/09 of restricted stock units under employer plan - data provided by plan administrator on 05/06/09. Vesting occurs 25% per year over four years.
- (2) Shares withheld to cover required tax withholding on vesting of restricted stock effective as of 05/04/09 - data provided by plan administrator on 05/06/09.
- (3) With tandem tax withholding right
- (4) Stock option granted 05/06/2009 under employer plan - data received from the plan administrator on 05/07/2009. Exercisable ratably over four years beginning 05/06/2010.
- (5) One share of Apache common stock for each restricted stock unit.
- (6) Restricted units granted 05/06/2009 under employer plan - data received from plan administrator on 05/07/2009. The units vest 25% per year on 06/01/2010, 05/06/2011, 05/06/2012 and 05/06/2013.
