This Amendment No. 8 to Schedule 13D amends and supplements the Schedule 13D, as amended, filed by the Reporting Persons with respect to the common stock, par value \$0.01 (<u>Common Stock</u>), of Industrial Distribution Group, Inc. (the <u>Issuer</u>). Except as set forth below, all previous Items remain unchanged. Capitalized terms used herein but not defined herein shall have the meanings given to them in the Schedule 13D, as amended, filed with the Securities and Exchange Commission. Each of the Reporting Persons hereby expressly disclaims beneficial ownership of the securities reported herein, except to the extent of its pecuniary interest therein, and this Schedule 13D shall not be deemed to be an admission that any such Reporting Person is the beneficial owner of the securities reported herein for purposes of the Securities Exchange Act of 1934 or for any other purpose.

## **Item 4. Purpose of Transaction**

Item 4 is hereby supplemented as follows:

On April 25, 2008, two affiliates of the Reporting Persons, Eiger Holdco, LLC (<u>Parent</u>) and Eiger Merger Corporation (<u>Merger Sub</u>), entered into an Agreement and Plan of Merger (the <u>Merger Agreement</u>) with the Issuer to acquire all of the outstanding shares of Common Stock for \$12.10 per share in cash on the terms and conditions set forth therein (the <u>Transaction</u>). The Merger Agreement is attached hereto <u>as Exhibit</u> 8 and incorporated by reference herein. In connection with the Merger Agreement, PDP delivered a commitment letter to Parent confirming that it will provide or cause to be provided to Parent cash in an amount equal to the Merger Consideration (as defined in the Merger Agreement) for purposes of the Transaction or, under certain circumstances, an amount equal to the amount payable by Parent to the Issuer upon termination of the Merger Agreement (the <u>PDP Commitment Letter</u>). PDP s obligations under the PDP Commitment Letter to provide cash equal to the Merger Consideration are subject to the satisfaction of all conditions to the closing of the Transaction set forth in the Merger Agreement. The PDP Commitment Letter is attached hereto as Exhibit 9 and incorporated by reference herein.
