Mr. McDonald was awarded 102,389 restricted stock units on June 21, 2013, and 122,950 restricted stock units on July 1, 2015. The (1) restrictions lapsed on 1/3 of the vesting units (34,130 and 40,984 shares, respectively). Mr. McDonald elected to have Hecla Mining Company withhold 35,830 shares to cover his tax liability.
