- (2) Grant of option to purchase shares of common stock under the Ceridian Corporation 2004 Long-Term Stock Incentive Plan in a transaction exempt under Rule 16b-3(d). This option vests 15,233 shares on the first anniversary, 15,232 shares on the second anniversary and 15,232 shares on the third anniversary of the date of the grant.
