## SCHEDULE 13D

This Amendment No. 7 ("Amendment No. 7") to the Schedule 13D (as amended to date, the "Schedule 13D") filed by the Sumas Family Group, including Perry Sumas, James Sumas, Robert Sumas, William Sumas and John Sumas, is being filed on behalf of the Estate of Perry Sumas (the "Reporting Person") relating to shares of Class A Common Stock of Village Super Market, Inc., a New Jersey corporation (the "Issuer"), no par value per share. Except as expressly set forth herein, there have been no changes in the information set forth in the Schedule 13D.

Item 5. Interest in Securities of the Issuer

(b) The Reporting Person has the sole power to dispose of the shares of Class A Common Stock and Class B Common Stock held by the Reporting Person, and William Sumas and John Sumas, appointed voting trustees under the Will of the Perry Sumas, have the sole power to vote the shares of Class A Common Stock and Class B Common Stock held by the Reporting Person, that are beneficially owned by it as reported in this Amendment No. 7.

(c) Except as set forth herein, the Reporting Person has not engaged in any transactions with respect to the Issuer's Class A Common Stock or Class B Common Stock in the past sixty (60) days.
