#### Item 1.01 ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT.

#### Amended and Restated Financing Commitment Letter

As previously reported in its Current Report on Form 8-K filed on June 14, 2018 (the <u>"Prior Report</u>"), Interface, Inc. (the <u>"Company</u>") entered into a commitment letter (the <u>"Financing Commitment Letter</u>") with Bank of America, N.A. (<u>"BOA</u>") and Merrill Lynch, Pierce, Fenner & Smith Incorporated (<u>"MLPFS</u>" and together with BOA, collectively, the <u>"Commitment Parties</u>") on June 14, 2018, pursuant to which the Commitment Parties agreed to arrange and provide the Company with a senior secured incremental term loan in an aggregate principal amount of \$465 million, available to the Company in Dollars or Euros, on the terms and subject to the conditions set forth in the Financing Commitment Letter.

On June 20, 2018, the Company entered into an amended and restated commitment letter with BOA, MLPFS and JPMorgan Chase Bank, N.A. (<u>"JPM</u>") (the <u>"Amended and Restated Financing Commitment Letter</u>"), pursuant to which the Financing Commitment Letter was amended and restated to (a) add JPM as a Commitment Party, whereby JPM will provide a portion of the financing described in the Financing Commitment Letter and JPM (or its affiliate) will act as joint lead arranger in connection with such financing, and (b) to make certain other conforming changes. All other material terms and conditions of the Financing Commitment Letter, as previously summarized in the Prior Report, remain unchanged.

JPM or its affiliates have engaged in, and may in the future engage in, commercial or investment banking, corporate trust or other commercial dealings in the ordinary course of business with the Company or its affiliates. JPM or its affiliates have received, or may in the future receive, customary fees and commissions for these transactions. Without limitation, JPM is a lender, and was a syndication agent, arranger and bookrunner, under the Company's existing credit facility.

The foregoing description of the Amended and Restated Financing Commitment Letter is qualified in its entirety by reference to the full text of such document, which is attached hereto as Exhibit 10.1 and is incorporated herein by reference.
