Section 240.13d-3, the Adviser may be deemed to beneficially own an aggregate of 5,907,088 Shares, or 9.42% of the Shares issued and outstanding as of November 2, 2018. Roderick Wong is the Managing Partner of the Adviser. The beneficial ownership percentage reported herein is based on 62,731,942 voting Shares issued and outstanding as of November 2, 2018, as disclosed in the Company’s most recent Form 10-Q, as filed with the Securities and Exchange Commission on November 7, 2018. This report shall not be deemed an admission that the Adviser, the Funds or any other person is the beneficial owner of the securities reported herein for purposes of Section 13 of the Securities Exchange Act of 1934, as amended, or for any other purpose.
