As the investment adviser to the Funds, AWM holds sole voting and investment power over 2,291,720 shares of Common Stock of the Issuer (the Shares) held by SSFQP, 732,992 Shares held by SSPE, 266,756 Shares held by TECH and 1,659,238 Shares held by TECH II.
