(1) Represents shares issued on settlement of Restricted Stock Units ("RSUs") granted to the reporting person, of which 2,152 shares were withheld upon vesting to satisfy tax withholding obligations. The grant of these RSUs was previously reported on Table II of a form 4 filed by the reporting person.
