(1) Fractional shares of Kinder Morgan Management, LLC ("KMR") that were received by the Reporting Person as part of quarterly share distributions paid by KMR were maintained by his broker in a separate account. These fractional shares accumulated to approximately two KMR shares owned by the Reporting Person. The purpose of this amendment is to include these accumulated fractional shares in the number of KMR shares reported in footnote (2) as being exchanged in the KMR merger.

(2) Received in exchange for 1,438 shares of Kinder Morgan Management, LLC ("KMR") in connection with the merger of KMR with a subsidiary of Kinder Morgan, Inc. ("KMI"). On November 26, 2014, the last trading day for the KMR shares, the closing price of KMR's shares was \$104.71 per share, and the closing price of KMI's Class P common stock was \$42.32 per share.

(3) Includes 125,787 shares subject to forfeiture restrictions that lapse on July 16, 2018.
