(a) Amount Beneficially Owned:

As of the close of business on October 8, 2018, BRPLP beneficially owned 382,414 shares of Common Stock. BRPGP is the general partner of BRPLP. BRCM is an investment advisor to BRPLP. As a result, each of BRPGP and BRCM may be deemed to beneficially own the 382,414 shares of Common Stock owned directly by BRPLP.

As of the close of business on October 8, 2018, BRFBF, beneficially owns 2,236,659 shares of Common Stock.

As of the close of business on October 8, 2018, BRF as the parent company of BRFBF and BRCM may be deemed to beneficially own the 2,619,073 shares of Common Stock beneficially owned in the aggregate by BRCM and BRFBF.

The foregoing should not be construed as an admission by any Reporting Person as to beneficial ownership of any shares of Common Stock owned by another Reporting Person. Each of the Reporting Persons disclaims beneficial ownership of the shares of Common Stock that are not directly owned by such Reporting Person, except to the extent of their pecuniary interest therein.

(b) Percent of Class:

As of the close of business on October 8, 2018, BPOF beneficially owns 1.5% of the outstanding shares of Common Stock. BRCM, as the investment advisor of BPOF may be deemed to beneficially own 1.5% of the outstanding shares

of Common Stock, owned directly by BPOF.

As of the close of business on October 8, 2018, BRFBR, beneficially owns 8.7% of the outstanding shares of Common Stock.

As of the close of business on October 8, 2018, BRF as the parent company of BRFBR and BRCM may be deemed to beneficially own 10.2% of shares of outstanding shares of Common Stock, beneficially owned in the aggregate by BRCM and BRFBR.
