In 2013, the reporting person contributed 468,077 shares of Common Stock of the issuer to a grantor retained annuity trust (the "GRAT"), for which his sister is the trustee and for which he is the sole beneficiary for the life of the GRAT. On November 14, 2014, the reporting person, pursuant to provisions in the GRAT agreement, received back from the GRAT 398,554 shares of issuer Common Stock in exchange for other securities and cash of the reporting person. The value of the exchange was calculated based on the average of the high and low per share market prices of the issuer's Common Stock on the NYSE on November 14, 2014.

(2) On November 14, 2014, the GRAT returned 69,523 shares of issuer Common Stock to the reporting person as an annuity payment.
