  - (6) Shares held in October 2015 GRAT.
    - (7) Phantom Stock Units held for the benefit of reporting person as of March 31, 2017 based on the value of Humana common stock on a 1-for-1 basis, under the Humana Retirement Equalization Plan. The ending number of units reflects normal fluctuation due to changes in stock price.
    - (8) Any unvested equity will be cancelled as of March 31, 2017 per the Voluntary Release and Separation Agreement signed by Mr. Murray, as filed in the Company's 8-K.
