- (1) On December 14, 2010, the reporting person contributed 16,000 shares of NSC common stock to a grantor retained annuity trust for the benefit of himself and his three children. Upon termination of the trust on December 14, 2012, 1,020 of the shares were transferred to the reporting person's children. The remaining 14,980 shares were previously distributed to the reporting person and continue to be reported in this Form 4 as 'directly owned'.
 - (2) Excludes 10,377 shares which remain held indirectly in grantor retained annuity trusts (GRATs), previously held directly.
 - (3) Represents the approximate number of whole shares of Common Stock estimated -- on the basis of the unit accounting system used by the Plan Administrator -- as of December 17, 2012, to have been credited to the reporting person's account in the Norfolk Southern Corporation Thrift and Investment Plan (TIP), a trustee 401(k) plan.
