(b) In a Form 8-K filed by the Company with the Securities and Exchange Commission on July 28, 2017, the Company reported the anticipated retirement of its Chief Credit Officer, C. Douglas Lefferson. The Form 8-K stated that the timing of Mr. Lefferson's retirement had not yet been determined, and that Mr. Lefferson would transition from the role of Chief Credit Officer effective upon the closing of the Company's announced merger with MainSource Financial Group, Inc., which is expected to occur in the first quarter of 2018. On August 28, 2017, it was determined that Mr. Lefferson will be retiring as the Company's Chief Credit Officer effective September 30, 2017.
