- The reported transaction involves the amendment on December 21, 2010 of a restricted stock unit ("RSU") award granted on December 15, 2009, resulting in the deemed cancellation of such award and a grant of a replacement performance-based RSU award, which amended award was not reportable on Form 4. The performance terms of the replacement award provide that (i) 50% of the shares will vest on a graded basis upon achievement of certain levels of cumulative stock price performance against the performance of a defined peer group of other offshore drilling contractors and (ii) 50% of the shares will vest upon achievement of safety performance as measured by cumulative total recorded incident rate measured against the comparable metric reported by the International Association of Drilling Contractors.
