The shares will vest on March 31, 2017 if Farmer Mac meets certain performance objectives related to portfolio charge-offs and delinquencies, as specified in the related award agreement.

- (5) Exercisable beginning March 31, 2015 with respect to 1,180 shares, beginning March 31, 2016 with respect to 1,180 shares, and beginning March 31, 2017 with respect to 1,180 shares.
