These shares were acquired during the fiscal year pursuant to the dividend reinvestment component of the nonqualified deferred compensation plan which was frozen on 12/31/2004.
  - (2) Upon separation from service from the Board, phantom stock units will be settled in cash at the then current market price of common stock.
