Exempt grant of Restricted Stock Award subject to the following vestings provisions: (1) 5% to vest each year in 2011 and 2012, (2) 10% to vest each year in 2013 to and including 2018, (3) 15% to vest each year in 2019 and 2020. Vesting is dependent upon achieving an (1) average five year trailing retained earnings annual growth rate of 10% (before dividends) to qualify for full vesting. Pro rata vesting will be applied down to 50% at a 5% growth rate. Shares that fail to vest will be forfeited and revert back to the Company's 2004 Equity Incentive Plan from which they were granted.
