Item 1. Security and Issuer.

This statement relates to the common stock, par value \$4.00 per share (the “Common Stock”), of First Mid-Illinois Bancshares, Inc., a Delaware corporation (the “Company”), whose principal executive offices are located at 1421 Charleston Avenue, Mattoon, Illinois 61938.

Item 2. Identity and Background.

a. Name

This statement is being filed by Steven L. Grissom individually and as more particularly described in Item 5 below.

Teresa A. Grissom is the spouse of Mr. Grissom

David R. Hodgman serves as co-trustees of the Lumpkin trusts described in Item 5 below.

Mary Lumpkin Sparks serves co-trustee of the Mary Lee Sparks 1978 Trust f.b.o. Mary Lee Sparks described in Item 5 below.

Mr. Grissom’s principal occupation is serving as the Administrative Officer of SKL Investment Group, LLC.

Mrs. Grissom’s principal occupation is an investor.

Mr. Hodgman’s principal occupation is working as an attorney with the law firm of Schiff Hardin, LLP.

Ms. Sparks’ principal occupation is an investor.

During the last five years, none of Mr. and Mrs. Grissom, Mr. Hodgman, and Ms. Sparks have been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).

Item 3. Source and Amount of Funds or Other Consideration.

Since Mr. Grissom's most recently filed statement on Schedule 13D on February 23, 2009, shares of Common Stock for which Mr. Grissom is reporting beneficial ownership herein have been acquired in the following manner: (i) 80 shares have been acquired pursuant to the deferral of director fees under the Company's Deferred Compensation Plan; (ii) 261 shares have been acquired pursuant to dividend reinvestment under the Company's Dividend Reinvestment Plan; (iii) 7,875 shares have been acquired pursuant to the exercise of outstanding stock options under the Company's Stock Incentive Plan; (iv) 6,122 shares have been acquired by the Richard Anthony Lumpkin 1990 Personal Income Trust f.b.o Benjamin Iverson Lumpkin and 6,122 shares have been acquired by the Richard Anthony Lumpkin 1990 Personal Income Trust f.b.o Elizabeth Arabella Lumpkin from a distribution of shares previously held by SKL Investment Group, LLC; (v) 300 shares have been acquired by the Mary Lee Sparks 1978 Trust f.b.o. Mary Lee Sparks from a distribution of shares previously held by Pinon Tree Holding Company; (vi) 9,080 shares are obtainable through the conversion of 40 shares of Series B 9% Non-Cumulative Perpetual Convertible Preferred Stock ("Series B") of the Company that have been acquired by the Richard Anthony Lumpkin 1990 Personal Income Trust f.b.o. Elizabeth Arabella Lumpkin from a purchase of shares from Elizabeth L. Celio; (vii) 12,552 shares have been acquired pursuant to Mr. Grissom's investment power over the Richard Adamson Lumpkin Trust dated

February 6, 1970 f.b.o. Mary Lee Sparks; (viii) 12,321 shares are obtainable through the conversion of 50 shares of Series C 8% Non-Cumulative Perpetual Convertible Preferred Stock ("Series C") of the Company that have been acquired pursuant to Mr. Grissom's investment power over the Richard Adamson Lumpkin Trust dated February 6, 1970 f.b.o. Mary Lee Sparks; (ix) 605 shares have been acquired pursuant to Mr. Grissom's investment power over the Richard Adamson Lumpkin Trust dated February 5, 1976 f.b.o. Mary Lee Sparks; (x) 5,874 shares have been acquired pursuant to Mr. Grissom's investment power over the John W. Sparks 2001 Irrevocable Trust dated July 5, 2001; (xi) 24,888 shares have been acquired pursuant to Mr. Grissom's investment power over the Richard Adamson Lumpkin Trust dated February 6, 1970 f.b.o. Margaret Lumpkin Keon; (xii) 18,501 shares are obtainable through the conversion of 80 shares of Series B Preferred Stock of the Company that have been acquired by the Richard Adamson Lumpkin Trust dated February 6, 1970 f.b.o. Margaret Lumpkin Keon; (xiii) 19,714 shares are obtainable through the conversion of 80 shares of Series C Preferred Stock of the Company that have been acquired by the Richard Adamson Lumpkin Trust dated February 6, 1970 f.b.o. Additionally, Mr. Grissom's percentage of beneficial ownership of shares of Common Stock has increased as a result of adjustments made to the Series B conversion price and also Common Stock repurchases under the Company's share buy-back program.

Item 4. Purpose of Transaction.

Purchases of shares of Common Stock by Mr. and/or Mrs. Grissom have been for investment purposes and by Mr. Grissom in his capacity as co-trustee of the trusts described in Item 5 below. Mr. Grissom may purchase additional shares from time to time depending upon price, market conditions, availability of funds, evaluation of other investment opportunities, and other factors. Although Mr. Grissom has no present intention to sell any shares, he could determine from time to time, based upon the same factors listed above for purchases, to sell some or all of the shares held by him.

Except as set forth above, Mr. Grissom does not have any plan or proposal which relates to any of the following matters:

- (a) The acquisition by any person of additional securities of the issuer, or the disposition of securities of the issuer;
- (b) An extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the issuer or any of its subsidiaries;

- (c) A sale or transfer of a material amount of assets of the issuer or of any of its subsidiaries;
- (d) Any change in the present board of directors or management of the issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board;
- (e) Any material change in the present capitalization or dividend policy of the issuer;
- (f) Any other material change in the issuer's business or corporate structure;
- (g) Changes in the issuer's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the issuer by any person;
- (h) Causing a class of securities of the issuer to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association;
- (i) A class of equity securities of the issuer becoming eligible for termination of registration pursuant to Section 12(g)(4) of the Securities Exchange Act of 1934; or
- (j) Any action similar to any of those enumerated above.

Mr. Grissom holds sole voting and investment power over the following shares of Common Stock: (i) 39,555 shares held individually, and (ii) 2,415 shares held for the account of Mr. Grissom under the Company's Deferred Compensation Plan, (iii) 3,375 shares which Mr. Grissom has the right to acquire by exercise of outstanding stock options under the Company's Stock Incentive Plan. Mr. Grissom holds shared voting and investment power over the following shares of Common Stock: (i) 9,213 shares held jointly by Mr. and Mrs. Grissom; (ii) 80 shares of Series B Preferred Stock of the Company, which are convertible into 18,501 shares of Common Stock of the Company, held jointly by Mr. and Mrs. Grissom.

Mr. Grissom also holds shared voting and investment power over the following shares held in trusts under which he serves as co-trustee: (i) 300 shares held by the Mary Lee Sparks 1978 Trust f.b.o. Mary Lee Sparks, under which Mr. Grissom serves as co-trustee; (ii) 173,096 shares held by the Richard Anthony Lumpkin 1990 Personal Income Trust for the Benefit of Benjamin Iverson Lumpkin dated April 20, 1990, under which Mr. Grissom serves as co-trustee; (iii) 250 shares of Series B Preferred Stock of the Company, which are convertible into 57,817 shares of Common Stock of the Company, held by the Richard Anthony Lumpkin 1990 Personal Income Trust for the benefit of Benjamin Iverson Lumpkin dated April 20, 1990; however, Mr. Grissom disclaims beneficial ownership of these 231,213 shares held by the foregoing trusts.

Mr. Grissom holds sole voting and investment power over the following shares held in trusts under which he serves as trustee: (i) 600 shares held by the Elizabeth L. Celio 2000 Gift Trust dated December 20, 2000 f.b.o. Emma G. Celio; (ii) 600 shares held by the Elizabeth L. Celio 2000 Gift Trust dated December 20, 2000 f.b.o. Claudia M. Celio; (iii) 600 shares held by the Elizabeth L. Celio 2000 Gift Trust dated December 20, 2000 f.b.o. Gabriela C Celio; however, Mr. Grissom disclaims beneficial ownership of these 1,800 shares held by the foregoing trusts.

Additionally, Mr. Grissom holds sole voting and investment power over the shares held in the following trusts: (i) 12,552 shares held by the Richard Adamson Lumpkin Trust dated February 6, 1970 f.b.o. Mary Lee Sparks; (ii) 50 shares of Series C Preferred Stock of the Company, which are convertible into 12,321 shares of Common Stock of the Company, held by the Richard Adamson Lumpkin Trust dated February 6, 1970 f.b.o. Mary Lee Sparks; (iii) 605 shares held by the Richard Adamson Lumpkin Trust dated February 5, 1976 f.b.o. Mary Lee Sparks; (iv) 5,874 shares held by the John W. Sparks 2001 Irrevocable Trust dated July 5, 2001; (v) 24,888 shares held by the Richard Adamson Lumpkin Trust dated February 6, 1970 f.b.o. Margaret Lumpkin Keon; (vi) 80 shares of Series B Preferred Stock of the Company, which are convertible into 18,501 shares of Common Stock of the Company, held by the Richard Adamson Lumpkin Trust dated February 6, 1970 f.b.o.
