On May 12, 2015, Qumu Corporation (the “Company”) held its Annual Meeting of Shareholders (the “Annual Meeting”). Of the 9,138,125 shares of the Company’s common stock outstanding and entitled to vote at the Annual Meeting on the April 1, 2015 record date, 8,397,280 shares, or approximately 91.9%, were present at the Annual Meeting either in person or by proxy.

The following describes the matters considered by the Company’s shareholders at the Annual Meeting, as well as the results of the votes cast at the meeting:

1. To elect six (6) directors of the Company to serve until the next Annual Meeting of Shareholders or until their respective successors have been elected and qualified.
