(1) On June 21, 2016, the reporting person exercised 6,000 stock options, delivered 4,260 shares of Common Stock of the Company for cancellation in payment of the exercise price of such options, and had 637 shares of Common Stock of the Company withheld and cancelled to cover minimum required tax withholding. These share cancellations are shown in Table I as dispositions (Transaction Code "D" in Column 4), although none of these cancelled shares were sold in the market, as indicated by Transaction Code "F" in Column 3.
