CVRD: Record Exports of Iron Ore and Pellets

Rio de Janeiro, July 4, 2002 - Companhia Vale do Rio Doce (CVRD) exports of iron ore and pellets for the first six months of 2002 reached an all time high of 54.910 million tons, an yoy increase of 8.4%.

In terms of exports, June was the second best month in the history of CVRD, with 10.363 million tons, behind March 2002, when 10.627 million tons were exported.

This figure includes CVRD Parent Company exports plus its subsidiary Urucum Mineracao and its pelletizing joint ventures (Nibrasco, Itabrasco, Kobrasco and Hispanobras).
