Mr. Maltese directly owned no shares of Common Stock. By reason of his position as Managing Member of (ii) MCM, Mr. Maltese may be deemed to beneficially own 449,462 shares of Common Stock held of record by certain clients of MCM, constituting approximately 5.06% of the shares outstanding.
